## **MOTHER'S DAY WALKING TOUR IN LOWERTOWN, SAINT PAUL, Sunday, May 11, 2014**

Join members and friends of the Cass Gilbert Society as we tour Lowertown to view the architecture of Cass Gilbert and his contemporaries. Lowertown grew up at the "Lower Landing" on the Mississippi River, beginning in the 1840s. As St. Paul grew, Lowertown evolved into a major warehouse and distribution center serving the entire Upper Midwest. Lowertown's railroad, manufacturing, and wholesaling companies expressed their pride and permanence in the structures they erected, beginning in the 1880s. A significant concentration of these buildings survive, unified by similar architectural styles and construction materials. Many were designed by Cass Gilbert and Clarence Johnston; they offer a stark contrast to the residential buildings by these architects, although some were for the same clients. The tour will be led by Marjorie Pearson, Ph.D., past president of the Cass Gilbert Society and *Newsletter* editor. It will focus on the role of the railroads, the relation to banking, and the development of the warehouse type in the late nineteenth and early twentieth centuries.

Meet at **Union Depot**, 214 East 4<sup>th</sup> Street at Sibley, starting at **2 p.m.** and lasting about two hours. Cost: \$15 per person, cash or check, payable at the beginning of the tour. The tour will proceed rain or shine, with a skyway backup in case of a downpour.

## **CELEBRATE PRESERVATION MONTH WITH THE PRESERVATION ALLIANCE OF MINNESOTA**

The Preservation Alliance of Minnesota (PAM) is hosting a celebration and open house at the **Pioneer-Endicott Buildings**, 141 East 4<sup>th</sup> Street, St. Paul, on **Tuesday, May 20, 2014, 6-8 p.m.** The Endicott Building, designed by Cass Gilbert and built in 1890, is connected to the Pioneer Building, designed by Chicago-based architect Solon S. Beman and built in 1889. These two office buildings, joined internally as part of a renovation in the 1980s, have been converted to apartments, along with commercial space and the new home of the Minnesota Museum of Art. Once again, Roselawn Cemetery welcomes visitors on **May 24, 25, and 26, 2014**, between 10 a.m. and 4 p.m. to visit the cemetery chapel (1902-1904) designed by Cass Gilbert and Thomas Holyoke in the style of a medieval English country church. There will be an organ concert each day beginning at 11 a.m. While the cemetery, planned by Gilbert in 1902, and the cemetery office building, also by Gilbert and Holyoke, are open to visitors all year, the chapel is normally open only for funerals and memorial services. 
### 100 Years of Student Drawings: Celebrating the School of Architecture's Centennial

In honor of its 100<sup>th</sup> anniversary, the University of Minnesota School of Architecture organized this exhibition of drawings, ranging from the Beaux-Arts era through the digital age. The earlier drawings reflect the sensibility employed by Gilbert, Johnston, and other contemporaries. **Through June 29, 2014**. Northrop Gallery, Northrop Hall, University of Minnesota, open every day during building hours.

### Palaces for the People: Guastavino and the Art of Structural Tile

This exhibition, originally organized by the Boston Public Library and expanded in its current venue at the Museum of the City of New York, examines the engineering and architectural beauty of spaces designed and built by the Spanish Catalan immigrants Rafael Guastavino and his son, Rafael, Jr. It features objects, artifacts, photographs, and documents on the Guastavinos' thin-shell structural vaults used on more than 1,000 significant architectural spaces in the United States. Cass Gilbert may have first encountered the work of the Guastavinos through McKim, Mead & White. Guastavino vaulting can be found in many of Gilbert's buildings including the Minnesota State Capitol, St. Paul; Roselawn Chapel, Roseville, Minnesota; U.S. Custom House, New York; Essex County Courthouse, Newark; St. Louis Art Museum; St. Louis Public Library; Detroit Public Library; Oberlin Art Gallery; and the Woolworth Building. Original drawings for the design and engineering details of the U.S. Custom House are featured in the exhibit. The exhibition website incorporates an online database, based on the research work of John Ochsendorf, designed for crowd-sourcing that allows visitors to submit photographs and information on any Guastavino projects they discover. ## **HONORING THE THURGOOD MARSHALL U.S. COURTHOUSE**

Cass Gilbert's last building, the **U.S. Courthouse on Foley Square** in lower Manhattan, re-opened last year after a six-year rehabilitation and restoration campaign. With its prominent location, soaring height, and gilded pyramidal roof, the courthouse is a major presence on the New York skyline. The building and the team involved in the project will be honored on June 5, 2014, with the Chairman's Award presented by the New York Landmarks Conservancy. The Chairman's Award is the Conservancy's highest honor recognizing exceptional business leaders or organizations that have demonstrated their dedication to protecting New York's architectural legacy, breathing life into the unique character of New York City.

## **WHO BUILT OUR CAPITOL?**

The Labor Education Service, University of Minnesota, has released **Who Built Our Capitol? The Lives and Work of the Men and Women Who Built the Minnesota State Capitol Building**, directed by Randy Croce. The 47 minute documentary has had several showings to interested groups around the state and can be viewed in its entirety through the accompanying website, [www.whobuiltourcapitol.org](http://www.whobuiltourcapitol.org). The website also provides access to photographs, interviews, and much of the background information that provided the basis for the film. John Sielaff, one of the project researchers, is also the author of "The Stonecutters," published in the Spring 2014 issue of *Minnesota History*. The illustrated article provides extensive information and background on these skilled workers.

## **A WOOLWORTH CELEBRATION**

The 100<sup>th</sup> anniversary of the completion of the Woolworth Building on April 24, 1913, was celebrated last year in a variety of ways. The exhibition, **The Woolworth Building @ 100**, at the Skyscraper Museum, featured a half-day symposium on June 14, 2013, that brought together eight scholars to discuss architecture and modernity in relation to the Woolworth Building. Shortly before the beginning of Woolworth Week, the **New-York Historical Society** announced that it had purchased the commemorative Tiffany bowl, presented to Cass Gilbert on April 24, 1913, which had been placed for auction by the heirs of Cass Gilbert III. As the depository of the most extensive collection of Cass Gilbert drawings and papers, the Society saw the bowl as a fitting acquisition. The bowl has been installed in the lobby of the New-York Historical Society building.
